ORDER

On June 18, 2024, Licking Valley Rural Electric Cooperative Corporation (Licking Valley RECC) filed a motion pursuant to 807 KAR 5:001, Section 5(1), requesting an extension of time to respond to the Commission Staff's First Rehearing Request for Information that was issued on June 4, 2024, and which required Licking Valley RECC to file its responses on or before June 18, 2024.<sup>1</sup> In its motion, Licking Valley RECC requested an extension to file its responses on or before June 21, 2024.

As grounds for its motion, Licking Valley RECC stated it contracted with a consultant to prepare the information and responses to Commission Staff's First Rehearing Request for Information and requested the extension until June 21, 2024, due to competing deadlines in the consultant's schedule.<sup>2</sup>

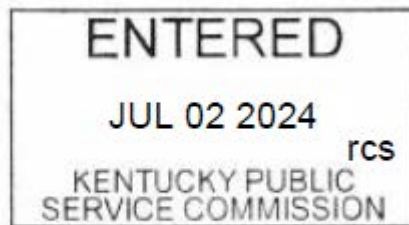
