<u>ORDER</u>

This matter arises from a complaint filed by Jeffrey Jon Greenberg in which he alleged that Louisville Gas and Electric Company (LG&E) cut off his household's electric service without notice. The Commission issued an Order on November 15, 2023, finding that LG&E violated 807 KAR 5:006, Section 15(1)(g) by failing to provide subsequent notice that it had terminated service due to evidence of theft and tampering, based on LG&E's admission that it had not provided such notice, and requiring LG&E to show cause why it should not be subject to penalties pursuant to KRS 278.990.

On December 5, 2023, LG&E filed its response to the Commission's Order of November 15, 2023, and a motion to dismiss the complaint with a proposed settlement agreement. Within the settlement agreement LG&E offered to pay the maximum fine of \$2,500 as set forth in KRS 278.990(1) in exchange for the dismissal of this case. LG&E requested that this case be dismissed upon payment of the \$2,500 penalty. Pursuant to the information of record in this matter indicating that LG&E was aware of but did not

provide notice required by Section 15 (1)(g) of 807 KAR 5:006, the Commission finds that this matter should be dismissed upon LG&E's payment of a \$2500 penalty imposed pursuant to KRS 278.990(1).

IT IS THEREFORE ORDERED that:

- 1. Pursuant to KRS 278.990(1), LG&E is fined and shall remit \$2,500 to the Commission within 20 days of the service of this order.
- 2. This case and the show cause order shall be dismissed and removed from the docket upon LG&E's payment of the \$2,500 penalty.
- 3. A copy of this Order shall be served on the Complainant, Jeffrey Jon Greenberg, by U.S. certified mail, return receipt requested at 7000 Hadley Ct. Louisville, Kentucky 40241.
