ORDER

On March 4, 2024, the Commission issued an Order<sup>1</sup> in this matter approving adjustments to water service rates for Montgomery County Water District #1 (Montgomery District #1) in its application for a rate adjustment pursuant to 807 KAR 5:076. Appendix B to the Order, Monthly Water Rates, contained two typographical errors. First, there was an error listing the last rate step of “Over 10,000 Gallons” as \$0.0922 Per Gallon, instead of the correct rate of \$0.00922 Per Gallon, and a second error listing the “Wholesale Rates” as \$0.0530 Per Gallon, instead of the correct rate of \$0.00530 Per Gallon.

Finding that the March 4, 2024 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The Monthly Water Rates section of Appendix B to the March 4, 2024 Order is stricken and replaced with the Monthly Water Rates section of the Appendix to this Order.
2. The adjusted rates in the Appendix to this Order are fair, just and reasonable.

3. All other provisions of the Commission's March 4, 2024 Order that are not in conflict with the terms of this Order shall remain in effect.

4. Within 20 days of the date of service of this Order, Montgomery District #1 shall file with the Commission revised tariff sheets containing the approved rates.

5. Montgomery District #1 shall collect any under collection or issue any refund, over a period of four months, for any difference between the rates for retail water service placed into effect following the March 4, 2024 Order, and the rates provided in the Appendix to this Order.

6. Within 20 days of the date of this Order, Montgomery District #1 shall file in this case a statement detailing the amounts billed to its retail customers in excess of the rates authorized in this Order with totals for each type of charge separately stated.
