ORDER

On December 19, 2023,¹ Garrison-Quincy-KY-O-Heights Water District (Garrison-Quincy-KY-O-Heights District) filed its application with the Commission requesting an adjustment to its water service rates pursuant to 807 KAR 5:076, Garrison-Quincy-KY-O-Heights District did not request an adjustment to its wastewater rates in the case. To comply with the requirements of 807 KAR 5:076, Section 9,² Garrison-Quincy-KY-O-Heights District used the calendar year ended December 31, 2022, as the basis for its application. Garrison-Quincy-KY-O-Heights District's last base rate increase pursuant to the alternative rate filing procedure was in Case No. 2021-00094.³ To ensure the orderly review of the application, the Commission established a procedural schedule by Order

dated January 10, 2024,⁴ which was subsequently amended by Order dated February 1, 2024.⁵ Garrison-Quincy-KY-O-Heights District responded to two information requests from Commission Staff and provided a supplemental response along with its response to Commission Staff's Report on May 8, 2024.⁶

Commission Staff issued its report (Commission Staff's Report) on April 30, 2024, summarizing its recommendations regarding Garrison-Quincy-KY-O-Heights District's requested rate adjustments. In the Commission Staff's Report, Commission Staff recommended that Garrison-Quincy-KY-O-Heights District's adjusted test year operations support an overall revenue requirement of \$690,564, and that a \$186,259 revenue increase, or 41.66 percent, to pro forma present rate revenues was necessary to generate the overall revenue requirement. Commission Staff's proposed increase was 10.07 percent higher than Garrison-Quincy-KY-O-Heights District's proposed increase.

On May 8, 2024, Garrison-Quincy-KY-O-Heights District filed its response to Commission Staff's Report.⁸ First, it requested that the late payment charge, which is

currently listed as \$7,9 be changed to 10 percent and submitted a cost justification for the change. Second, Garrison-Quincy-KY-O-Heights District stated that it did not agree with the removal of certain labor expensed from nonrecurring charges, but it did not wish to contest that adjustment in this case. Garrison-Quincy-KY-O-Heights District concurred with the remainder of the findings presented in Commission Staff's Report. Garrison-Quincy-KY-O-Heights District waived its right to request an informal conference or formal hearing. Finally, Garrison-Quincy-KY-O-Heights District requested that the Commission consider implementing the rate increase over two years.

Consistent with 807 KAR 5:076, Section 11(3)(f), Garrison-Quincy-KY-O-Heights District amended its application when it accepted Commission Staff's proposed rates that exceeded 110 percent of the total increase in revenues that Garrison-Quincy-KY-O-Heights District's proposed rates would produce. By Order entered July 2, 2024, the Commission accepted Garrison-Quincy-KY-O-Heights District's amended application and required Garrison-Quincy-KY-O-Heights District to notify its customers of the recommended rates calculated by Commission Staff. On July 22, 2024, Garrison-Quincy-KY-O-Heights District filed an affidavit with proof of public notice to its customers. The case now stands submitted for a decision by the Commission.

LEGAL STANDARD

Alternative rate adjustment proceedings, such as this one, are governed by Commission regulation 807 KAR 5:076, which establishes a simplified process for small utilities to use to request rate adjustments, with the process designed to be less costly to the utility and the utility ratepayers. The Commission's standard of review of a utility's request for a rate increase is well established. In accordance with KRS 278.030 and case law, the utility is allowed to charge its customers "only fair, just and reasonable rates." Further, the utility bears the burden of proof to show that the proposed rate increase is just and reasonable under KRS 278.190(3).

BACKGROUND

Garrison-Quincy-KY-O-Heights District is a water and sewer utility organized pursuant to KRS Chapter 74 that owns and operates a distribution system through which it provides retail water service to approximately 1,038 residential customers, 39 commercial customers, 1 industrial customers and 1 public authority that reside in Lewis County, Kentucky. Garrison-Quincy-KY-O-Heights District's sewer division owns and operates sewage facilities in Lewis County, Kentucky, that serve approximately 283 residential customers and 18 commercial customers. UNACCOUNTED-FOR WATER LOSS

The Commission notes that in its 2022 Water Division Annual Report, Garrison-Quincy-KY-O-Heights District reported a water loss of 26.2105 percent. Commission regulation 807 KAR 5:066, Section 6(3), states that for ratemaking purposes, a utility's water loss shall not exceed 15 percent of total water produced and purchased, excluding water consumed by a utility in its own operations. Garrison-Quincy-KY-O-Heights District both purchases and produces its water supply. Garrison-Quincy-KY-O-Heights District currently produces approximately 80 percent for its water needs and purchases the remaining 20 percent from Vanceburg Electric Plant Board. The table below shows that the 2022 total annual cost of water loss to Garrison-Quincy-KY-O-Heights District is \$21,881, while the annual cost of water loss in excess of 15 percent is \$9,359.

TEST PERIOD

The calendar year ended December 31, 2022, was used as the test year to determine the reasonableness of Garrison-Quincy-KY-O-Heights District's existing and proposed wastewater rates as required by 807 KAR 5:076, Section 9.

SUMMARY OF REVENUE AND EXPENSES

The Commission Staff's Report summarized Garrison-Quincy-KY-O-Heights District's pro forma income statement as follows.

REVIEW OF COMMISSION STAFF'S RECOMMENDATIONS

Garrison-Quincy-KY-O-Heights District proposed adjustments to its revenues and expenses to reflect current and expected operating conditions. In the Commission Staff's Report, Commission Staff proposed additional adjustments. Upon review, the Commission discovered Commission Staff incorrectly calculated an adjustment for Depreciation Expense. Commission Staff calculated the Depreciation Expense for new meter taps as \$121²³ because it separated the labor and materials and depreciated each over different service lives with labor being depreciated over 45 years and materials over

40 years. The Commission considers new water taps as a single asset to be depreciated instead of a collection of separate pieces. The Commission determined the asset's depreciation should be calculated over a 42.5-year service life.²⁴ Correction for the difference in useful service lives rates results in an increase to the Revenue Requirement of \$4. The Commission finds that this correction to Depreciation Expense is appropriate in order to properly record the service lives for new meter taps.

In addition, since Commission's Staff Report was issued, the contribution rate for the County Employee Retirement System (CERS) was reduced from 23.34 percent to 19.71 percent²⁵, which results in a decrease to the Revenue Requirement of \$7,705. The following is the Commission's complete pro forma:

Reclassify Other Water Revenues from Metered Water Sales. In its application, Garrison-Quincy-KY-O-Heights District proposed to reduce Metered Sales to Retail Customers by \$76,679 to reclassify revenues to their proper accounts. ²⁶ Of the \$76,679 proposed, \$48,660 was reclassified as revenues from sales for resale, \$23,429 was reclassified as forfeited discounts, and \$4,590 was reclassified as miscellaneous service revenues. ²⁷ Commission Staff agreed with these adjustments as these revenues were incorrectly reported as metered water sales and should be reported as revenues from the appropriate other water revenues categories. ²⁸

The Commission finds that Garrison-Quincy-KY-O-Heights District's adjustment is reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Metered Water Sales should be reduced by a total of \$76,679, to reflect the reclassification of different revenues into the correct revenue categories.

Remove Meter Tap Revenues. In its application, Garrison-Quincy-KY-O-Heights District proposed to decrease Metered Water Sales by \$7,950²⁹ to reflect the removal of meter tap fees,³⁰ During the test year, Garrison-Quincy-KY-O-Heights District reported

\$7,950 as revenues from water sales³¹ that, according to the Uniformed System of Accounting (USoA), should be recorded as Contributions in Aid of Construction and credited to Account 271 – Contributions in Aid of Construction.³² Therefore, Commission Staff agreed with this adjustment as it should not have been reported as revenue from water sales.³³

The Commission finds that Garrison-Quincy-KY-O-Heights District's adjustment is reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Metered Water Sales should be reduced by \$7,950 because the USoA requires that these fees be recorded as Contributions in Aid of Capital and not recorded as revenue.

Remove Sewer Connection Fees. In its application, Garrison-Quincy-KY-O-Heights District proposed an adjustment to decrease Metered Sales to Retail Customers by \$960³⁴ to reflect the reclassification of improperly recorded sewer connections fees.³⁵ Commission Staff agreed with the adjustment as the amount was incorrectly reported as revenue from water sales when it should have been reported as revenue from sewer connections.³⁶

The Commission finds that Garrison-Quincy-KY-O-Heights District's adjustment to reduce Metered Water Sales by \$960 for amounts that should have been recorded as Sewer Connection Fees is reasonable and should be accepted.

Billing Analysis Adjustment. Garrison-Quincy-KY-O-Heights District provided a billing analysis listing the water usage and water sales revenue for the 12-month test year in its application.³⁷ In the 2022 Water Division Annual Report, total metered water sales revenue reported for the test year is \$572,507.³⁸ The reclassification of the revenues described in previous adjustments results in revenue from water sales of \$535,578. Garrison-Quincy-KY-O-Heights District provided a billing analysis to calculate a normalized revenue amount based on the usage during the test year using the rates authorized in its current tariff to be \$447,073. Subsequently, Garrison-Quincy-KY-O-Heights District proposed to decrease test-year water sales revenue by \$88,505³⁹ to reflect the revenues from water rates generated by the billing analysis.⁴⁰ Commission Staff agreed with the proposed adjustment as the rates authorized by Garrison-Quincy-KY-O-Heights District's current tariff, when applied to its billing analysis, results in a proforma revenue from Metered Water Sales of \$447,073,⁴¹ a decrease of \$88,505.

The Commission finds that Garrison-Quincy-KY-O-Heights District's recommended adjustment is reasonable and should be accepted. Garrison-Quincy-KY-

O-Heights District's Metered Retail Sales should be decreased by \$88,505, because the adjustment to Metered Sales to Retail Customers is a known and measurable change reflected in the evidence provided in the record.

Miscellaneous Service Revenues – Nonrecurring Charges. Garrison-Quincy-KY-O-Heights District provided the number of instances each nonrecurring charge was performed during the test period. Using this information as well as the current nonrecurring charge amount listed in its current tariff, Commission Staff calculated test-period adjustment to revenue from Nonrecurring Charges of \$388. This results in an increase in the adjustment to Miscellaneous Service Revenues of \$780 in addition to the proposed increase of \$4,590 discussed in the Reclassify Other Water Revenues from Metered Water Sales adjustment. An additional adjustment to Nonrecurring Charges as discussed in the Nonrecurring Charges section below results in an increase to Miscellaneous Service Revenues of \$392. Therefore, Commission Staff recommended a total adjustment of \$780⁴³ to Miscellaneous Service Revenues for a final pro forma increase to Miscellaneous Service Revenues of \$5,370.⁴⁴

The Commission finds that the Commission Staff's recommendation is consistent with precedent, that labor expenses resulting from work performed during normal

business hours should not be recovered through nonrecurring charges. The Commission requires that charges be directly related to the actual cost incurred to provide the service. Only the marginal cost related to the service should be recovered through a nonrecurring charge for service provided during normal working hours. Thus, the Commission finds that Commission Staff's recommendation is reasonable, the revised nonrecurring charges as described in Appendix A to be reasonable and that Garrison-Quincy-KY-O-Heights District's Miscellaneous Service Revenue should be reduced by \$780 because only the incremental cost related to the service should be recovered for service provided during normal business hours.

Expenses Related to Meter Installations. In its application, Garrison-Quincy-KY-O-Heights District proposed an adjustment to decrease Salaries and Wages – Employees by \$3,975, and Materials and Supplies by \$3,975, ⁴⁶ to account for tap fee expenses that were included as part of these expenses during the test year. During the test year, Garrison-Quincy-KY-O-Heights District installed six new water connections. The USoA for Class A/B Water Systems requires that these costs be capitalized as Utility Plant in Service and depreciated over their estimated useful lives. Commission Staff agreed

with Garrison-Quincy-KY-O-Heights District's proposed adjustment.⁵⁰ Additionally, Garrison-Quincy-KY-O-Heights District confirmed that it did not capitalize the water tap labor, and only capitalized the cost of the new meter.⁵¹ Therefore, Commission Staff capitalized the labor costs and materials expense, and proposed a corresponding adjustment to test-year depreciation as shown below.⁵²

The Commission finds that Garrison-Quincy-KY-O-Heights District's adjustment is reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Salaries and Wages – Employees should be reduced by \$3,975, and Materials and Supplies should be reduced by \$3,975 because the USoA requires that costs be capitalized as utility plant in service and depreciated over their estimated useful lives.

<u>Salaries and Wages – Employees</u>. In the test year, Garrison-Quincy-KY-O-Heights District reported a test year Salaries and Wages – Employees of \$189,192.⁵³ As discussed above, Commission Staff recommended accepting Garrison-Quincy-KY-O-Heights District's adjustment to reduce Salaries and Wages – Employees by \$3,975 to account for the removal of Meter Installation labor as seen in the table above. Garrison-

Quincy-KY-O-Heights District provided its test-year and current employee list,⁵⁴ test year hours worked, employee wage rates,⁵⁵ and current staff levels.⁵⁶ Subsequent to the test year, employees' salaries were increased.⁵⁷ During the test year, employee position 6 left employment; two replacements were hired and subsequently left during the test year before a third employee was hired who is still with Garrison-Quincy-KY-O-Heights District.⁵⁸ Commission Staff calculated the pro forma Salaries and Wages – Employee amount utilizing the current number of employees, the test-year hours worked and the current wage rates⁵⁹ and calculated a total salaries and wages of \$212,248. Commission Staff recommended an adjustment to increase Salaries and Wages – Employees by \$27,031, as shown in the following table.⁶⁰

The Commission finds that Commission Staff's recommended adjustments are reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Salaries and Wages- Employees should be increased by \$27,031, because the adjustment to normalize Salaries and Wages – Employees is a known and measurable change reflected in the evidence provided in record.

<u>Salaries and Wages – Officers</u>. In the test year, Garrison-Quincy-KY-O-Heights District reported Salaries and Wages – Officers expense as \$8,139.⁶¹ Garrison-Quincy-KY-O-Heights District's Board consists of three commissioners. Garrison-Quincy-KY-O-Heights District submitted the Lewis County Fiscal Court minutes evidencing the commissioners were approved by the Fiscal Court and their salaries were established.⁶² The Lewis County Fiscal Court approved each commissioner to receive \$300 per month for an annual salary of \$3,600 which totals \$10,800 for the three Commissioners.

Garrison-Quincy-KY-O-Heights District allocates Commissioner salary expense between water and sewer based upon the number of customers.⁶³ Commission Staff calculated the allocations below, which result in a proposed increase of Salaries and Wages – Officers by \$305 as shown in the following table.⁶⁴

The Commission finds that Commission Staff's recommended adjustment is reasonable and Garrison-Quincy-KY-O-Heights District's Salaries and Wages – Officers should be increased by \$305 based on the evidence in the case record for commissioners' salaries as well as allocation methodology between water and sewer divisions.

Employee Pensions - County Employee Retirement System (CERS). Garrison-Quincy-KY-O-Heights District participates in the CERS, which is administered by the Kentucky Public Pension Authority (KPPA). The KPPA 2024 fiscal year (July to June) contribution rate was 23.34 percent. Garrison-Quincy-KY-O-Heights District reported retirement expense of \$58,243,66 which is comprised of employer contributions of \$58,243

and a reduction of expense of \$22,062 for certain accounting adjustments.⁶⁷ It did not propose any adjustments.

As discussed above, Commission Staff calculated a pro forma Salaries and Wages expense of \$212,248. Commission Staff recalculated the CERS contribution amount based on pro forma wages and the current contribution rate as shown in the table below.⁶⁸

The Commission finds that Commission Staff's recommendation should be modified since the contribution rate for CERS contribution was reduced from 23.34 percent to 19.71 percent effective July 1, 2024. Accounting for the current contribution percentage means Garrison-Quincy-KY-O-Heights District's CERS contribution should be decreased by \$16,409, which is \$7,705 more than Commission Staff recommended, as shown below.

The adjustment results in a decrease to the Revenue Requirement of \$7,705 and is a known and measurable change based upon Employee Salaries and the current CERS contribution rate, is reasonable and should be accepted.

Employee Pensions – Governmental Accounting Standards Board (GASB) 68 and 75. In the application, Garrison-Quincy-KY-O-Heights District included in its calculation of Employee Pensions a decrease to Employee Pensions and Benefits expense by \$22,062 to conform to GASB 68 and 75 Standards.⁶⁹ In Case No. 2016-00163,⁷⁰ Commission Staff discussed in detail how reporting requirements for GASB 68 would affect a utility's income statement and balance sheet. In that proceeding, Commission Staff noted that the annual pension expense should be equal to the amount of a district's contributions to CERS, which historically have been fairly constant. Consistent with

Commission's precedent,⁷¹ Commission Staff removed the \$22,062 adjustment related to GASB 68 and 75.⁷²

The Commission finds that Commission Staff's recommended adjustment is reasonable, and Garrison-Quincy-KY-O-Heights District's Employee Pensions should be increased by \$22,062 to reflect Commission precedent in recording adjustments related to GASB 68 and 75.

Employee Benefits – Health Insurance Stipend. Garrison-Quincy-KY-O-Heights District does not provide medical insurance to employees. Instead, it provides employees a \$350 per month reimbursement for health insurance.⁷³ In its application, Garrison-Quincy-KY-O-Heights District reported the reimbursement as Insurance – Other expense.⁷⁴ Since health insurance is considered an employee benefit, Commission Staff reclassified it from Insurance – Other to Medical Insurance Stipend.

Commission Staff calculated the annual reimbursement expense by multiplying the \$350 per month by six full-time employees, resulting in a total stipend amount of \$25,200.⁷⁵ Then, Commission Staff calculated the water division allocation. The allocation factor used was based on the amounts directly charged to water and sewer

division during the test year;⁷⁶ therefore, 79.33 percent of the total reimbursement is allocated to the water division and 20.67 percent to the sewer division, as shown in the following table:

Using the 79.33 percentage allocation factor, Commission Staff calculated \$19,991 to be allocated to the water division. Therefore, Commission Staff recommended increasing Medical Insurance Stipend by \$19,991.⁷⁷ Commission Staff also proposed to reduced Insurance – Other by the test year amount of \$17,794, in order to properly categorize the stipend as an employee benefit, as shown in the following table:⁷⁸

The Commission finds that Commission Staff's recommended adjustments are reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Insurance - Other should be reduced by \$17,794, to reflect the reclassification of health insurance

benefits to its correct category. In addition, Garrison-Quincy-KY-O-Heights District's Health Insurance Stipend should be increased by \$19,991, to reflect Garrison-Quincy-KY-O-Heights District's allocation methodology as well as current health insurance stipend amount, as evidenced in the case record.

Purchased Water Expense Normalization. During the test year, Garrison-Quincy-KY-O-Heights District reported a Purchased Water expense of \$32,351.⁷⁹ Commission Staff calculated the Purchased Water expense using the test year gallons purchased of 19,018,560,⁸⁰ at the current wholesale tariff rate of \$1.68 per 1,000 gallons,⁸¹ which results in a \$400 decrease to Purchased Water Expense as shown in the table below.⁸²

The Commission finds Commission Staff's recommended adjustment is reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Purchased Water expense should be decreased by \$400, because the adjustment is based on the test year gallons purchased at current rates.

Chemical Expense Normalization. During the test year, Garrison-Quincy-KY-O-Heights District reported a Chemical Expense of \$13,258.⁸³ In order to normalize the Chemical costs, Commission Staff calculated a revised pro forma Chemical Expense using the test year volumes purchased,⁸⁴ multiplied by the current unit price paid for each chemical.⁸⁵ This resulted in a chemical expense of \$14,227. Therefore, Commission Staff proposed to increase Chemical Expense by \$1,041, as shown in the following table:⁸⁶

expense should be increased by \$1,041, because the adjustment is based on the test year volumes purchased at current rates.

Excess Water Loss. In its application, Garrison-Quincy-KY-O-Heights District proposed adjustments to decrease Purchased Water expense by \$3,627, Purchased Power expense by \$4,174, and Chemicals expense by \$1,486.87 The adjustments are to reflect the expense for water loss in excess of 15 percent.88 During the test year, Garrison-Quincy-KY-O-Heights District reported water loss of 26.2105 percent.89 As noted earlier, Commission regulations prohibit the recovery of expenses for water loss in excess of 15 percent. Commission Staff calculated a net decrease of \$3,582 to Purchased Water expense, which is \$45 less than proposed by Garrison-Quincy-KY-O-Heights District reduced Purchased Power Expense by \$4,174 and Commission Staff agreed with the adjustment.91 Commission Staff proposed to reduce Chemical Expense by \$1,603, which is \$117 more than proposed by Garrison-Quincy-KY-O-Heights District, as shown in following table:92

The Commission finds Commission Staff's recommended adjustment is reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Purchased Water expense should be decreased by \$3,582, Purchased Power expense decreased by \$4,174, and Chemical Expense should be decreased by \$1,603 since Commission regulation 807 KAR 5:066, Section 6(3), limits water loss to 15 percent for ratemaking purposes.

Depreciation Expense. Garrison-Quincy-KY-O-Heights District proposed an increase in Depreciation Expense by \$9,854⁹³ to adjust the service lives of assets using the National Association of Regulatory Utility Commissioners (NARUC) titled Depreciation Practices for Small Water Utilities (NARUC Study).⁹⁴ To evaluate the reasonableness of the depreciation practices of small water utilities, the Commission has historically relied upon the same NARUC Study published in 1979. When no evidence exists to support a specific life that is outside the NARUC ranges, the Commission has historically used the midpoint of the NARUC ranges to depreciate the utility plant. Upon examination, Commission Staff agreed with Garrison-Quincy-KY-O-Heights District's methodology to adjust depreciation expense.⁹⁵ However, Commission Staff calculated a

depreciation expense of \$117,588. Commission Staff found no evidence to support depreciable lives that vary significantly from the midpoint of the NARUC ranges. Therefore, Commission Staff proposed to increase Garrison-Quincy-KY-O-Heights District's Depreciation Expense by \$16,083, which is \$6,229 more than proposed by Garrison-Quincy-KY-O-Heights District, as shown in the following table.⁹⁶

The Commission finds Commission Staff's recommended adjustment is reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Depreciation Expense should be increased by \$16,083, in order to align Garrison-Quincy-KY-O-Heights District's capital assets' useful lives with the NARUC recommended useful lives.

<u>Capitalization of Tap Labor Expenses</u>. As explained in the expenses related to meter installations adjustment, the expenses related to the installation of new water connections are capital expenditures that should be capitalized as Utility Plant in Service

and depreciated over their estimated useful lives. Garrison-Quincy-KY-O-Heights District confirmed that it already capitalized \$444 for the cost of the new meters, ⁹⁷ but did not capitalize the labor costs or the remaining materials used. ⁹⁸ Therefore, \$2,663 is already capitalized as part of Pumping Equipment. ⁹⁹ Garrison-Quincy-KY-O-Heights District confirmed that it did not include the amount capitalized for either labor or materials in the proposed adjustment to Depreciation Expense. ¹⁰⁰ As such, Commission Staff calculated the annual depreciation amount for the test year and increased depreciation expense by \$88 to account for the Tap Fee Labor Expense and \$33 for the remaining Tap Fee Material Expense, for a total increase of \$121 as shown below: ¹⁰¹

However, as stated above, the Commission finds Commission Staff's recommended adjustment is incorrect and should be modified since Commission Staff used separate service lives for separate portions of new meter taps; 45 years for the labor and 40 years for the materials rather than treating the new taps as a single asset to be depreciated over the NARUC Study's recommended 42.5 years. Depreciating the new taps over the single 42.5 years the Commission determined Garrison-Quincy-KY-O-Heights District's Depreciation Expense should be increased by \$125 instead of \$121, as shown below.

The adjustment results in an increase to the Revenue Requirement of \$4 and is consistent with past precedent regarding depreciating new Water Taps over a 42.5-year service life in their entirety.¹⁰² Therefore, the Commission finds that this adjustment is based on a known and measurable change, is reasonable and should be accepted.

Taxes Other Than Income – Reclassification of Sewer. Garrison-Quincy-KY-O-Heights District proposed an adjustment to decrease Taxes Other Than Income by \$3,864¹⁰³ to account for the reclassification of Payroll Taxes attributable to salaries paid for the sewer division. Commission Staff agreed the sewer division's expenses need to be included in the sewer expenses instead of the water division expenses. Garrison-Quincy-KY-O-Heights District calculated the amount of Payroll taxes incurred during the test year by the sewer division and proposed to remove from the total Taxes Other Than Income. Therefore, Commission Staff agreed with Garrison-Quincy-KY-O-Heights District's proposed adjustment and decreased Taxes Other Than Income by \$3,864.

The Commission finds that Garrison-Quincy-KY-O-Heights District's adjustment is reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Taxes other than Income should be reduced by \$3,864. The adjustment is to remove the Sewer payroll taxes from the Garrison-Quincy-KY-O-Heights District's Water Division's records.

Taxes Other Than Income- FICA. In the application, Garrison-Quincy-KY-O-Heights District reported \$20,083 for Taxes Other Than Income but revised it to \$17,542.¹⁰⁸ As discussed above, Commission Staff reduced Taxes Other Than Income by \$3,864. Commission Staff recalculated the payroll taxes, accounting for the

adjustments to Salaries mentioned above, Commission Staff calculated pro forma salaries and wages – Employees of \$212,248 and allocated Salaries and Wages – Officers of \$8,444. Therefore, Commission Staff calculated a pro forma Taxes Other Than Income of \$16,883, which is an increase of \$3,205,109 as shown in the following table:

The Commission finds that Commission Staff's recommended adjustments are reasonable and should be accepted. Garrison-Quincy-KY-O-Heights District's Taxes other than Income should be increased by \$3,205 because the known and measurable change is a direct result of changes to Salaries and Wages – Employees and Salaries and Wages – Officers.

SUMMARY OF ADJUSTMENTS

Based upon the Commission's findings discussed above, the following table summarizes Garrison Quincy-KY-O-Heights' adjusted pro forma:

OVERALL REVENUE REQUIREMENT AND REQUIRED REVENUE INCREASE

The Commission has historically applied a Debt Service Coverage (DSC) method to calculate the Overall Revenue Requirement of water districts and water associations.¹¹⁰ This method allows for recovery of (1) cash-related pro forma operating expenses; (2) recovery of depreciation expense, a non-cash item, to provide working capital;¹¹¹ (3) the average annual principal and interest payments on all long-term debts; and (4) working capital that is in addition to depreciation expense.

1. Average Annual Principal and Interest Payments. At the time of Commission Staff's review, Garrison-Quincy-KY-O-Heights District had four U.S. Department of Agriculture's Rural Development (RD) Bonds¹¹² and one Kentucky Infrastructure Authority (KIA) Ioan.¹¹³ In its application, Garrison-Quincy-KY-O-Heights District requested recovery of the average annual principal and interest on its indebtedness based on an average of the annual principal, and interest and fee payments for the five years following the test year, which is 2023 through 2027.¹¹⁴ However,

because the statutory date for a final Order to be issued in this proceeding is October 19, 2024, the 2023 debt service payments will be recovered through Garrison-Quincy-KY-O-Heights District's existing rates. Therefore, only the debt service payments that will be made after the new rates are placed into effect should be considered in determining Garrison-Quincy-KY-O-Heights District's Annual Principal and Interest Expense. Commission Staff calculated the average annual principal and interest on a five-year average for the years 2024 through 2028. As shown below, Commission Staff calculated an Average Principal and Interest expense of \$87,555.

The Commission finds Commission Staff's proposed Average Interest and Principal Payments of \$87,555 should be included in Garrison-Quincy-KY-O-Heights District's Revenue Requirement because the Debt Service Coverage methodology allows for the recovery of the principal and interest payments.

2. Additional Working Capital. The DSC method, as historically applied by the Commission, includes an allowance for additional working capital that is equal to the minimum net revenues required by a district's lenders that are above its average annual debt payments. In its application, Garrison-Quincy-KY-O-Heights District requested

recovery of an allowance for working capital that is equal to 120 percent of its average annual debt payments for its Bonds at the time of its application for a total of \$18,401. 115

Following the Commission's historic practice, ¹¹⁶ Commission Staff agreed with Garrison-Quincy-KY-O-Heights District's methodology. Therefore, when the change from 2023 through 2027 to 2024 through 2028 is taken into account, \$17,511 is included in the revenue requirement as shown in the following table:

The Commission finds Commission Staff's proposed Additional Working Capital of \$17,511 should be included in Garrison-Quincy-KY-O-Heights District's Revenue Requirement because the Additional Working Capital is a direct result of the calculated Annual Debt Principal and Interest payments.

RATE DESIGN

Garrison-Quincy-KY-O-Heights District proposed to allocate its increase across the board. Garrison-Quincy-KY-O-Heights District applied this across the board increase as no cost-of-service study (COSS) was performed. Garrison-Quincy-KY-O-Heights

District stated that a COSS was not completed as there had not been any material change in its water system to warrant a COSS.¹¹⁷ Commission Staff agreed with this allocation method and used it to allocate its recommended \$186,263 increase.

The Commission find that the allocation of a revenue increase evenly across the board to a utility's rate design is appropriate when there has been no evidence entered into the record demonstrating that this method is unreasonable and in the absence of a COSS. In the Commission Staff's Report, Commission Staff followed the method proposed by Garrison-Quincy-KY-O-Heights District and allocated Commission Staff's calculated revenue increase across the board to Garrison-Quincy-KY-O-Heights District's monthly retail water service rates.

In its response to Commission Staff's Report, Garrison-Quincy-KY-O-Heights District requested that the Commission implement a two-year phase-in of the overall increase. Having considered the evidence and the percentage of rate increase, the Commission agrees with a two-year phase-in implementation to reduce the impact of the increase on Garrison-Quincy-KY-O-Heights District's customers.

The rates, as calculated by Commission Staff, which are set forth in Appendix B to this report, are based upon the total revenue requirement of \$682,863 and will produce sufficient revenues from water sales to recover the \$625,631 Revenue Required from Water Sales. The rates in phase 1 will increase an average residential customer using 3,000 gallons monthly water bill from \$32.20 to \$38.92, an increase of \$6.72, or

approximately 20.86 percent.¹¹⁹ The rates in phase 2 will increase an average residential customer using 3,000 gallons monthly water bill of the phase 1 rates from \$38.92 to \$45.06, an increase of \$6.14, or approximately 15.78 percent.

Nonrecurring Charges. Following the Commission's recent decisions, 120 Commission Staff has reviewed Garrison-Quincy-KY-O-Heights District's Nonrecurring Charges. In Commission Staff's report, Staff noted that, while Garrison-Quincy-KY-O-Heights District did not request to revise the nonrecurring charges for its sewer division, it did provide updated cost justification sheets for each nonrecurring charge. 121 Commission Staff reviewed the cost justification sheets and made revisions to the charges for Garrison-Quincy-KY-O-Heights District's sewer division.

The Commission has found that, because district personnel are currently paid during normal business hours, estimated labor costs previously included in determining the amount of Nonrecurring Charges should be eliminated from the charges. Commission Staff reviewed the cost justification information provided by Garrison-Quincy-KY-O-Heights District and have adjusted these charges by removing Field Labor Costs and Office/Clerical Labor Costs. Such adjustments result in the Nonrecurring Charges shown in Appendix A.

In its response to Commission Staff's Report, Garrison-Quincy-KY-O-Heights District stated that its current tariff provides for a Late Payment Charge of \$7. Garrison-Quincy-KY-O-Heights District proposed to revise this charge to 10 percent as allowed by the Commission. The Commission agrees with this proposal and finds that it should be approved considering the 10 percent Late Payment Penalty is supported by statute. 123

The adjustments to the Nonrecurring Charges result in an increase in Miscellaneous Service Revenue of \$392 as shown below. The Commission finds that the revised nonrecurring charges recommended by Commission Staff are approved because they are supported by the expenses contained in the cost justification sheets.

In addition to its nonrecurring charges, Garrison-Quincy-KY-O-Heights District proposed to increase its Meter Tap-On Fees for all meter sizes from \$1,325 to \$1,420.

Commission Staff reviewed the cost justification sheets¹²⁴ provided by Garrison-Quincy-KY-O-Heights District and agreed with the proposed Meter Tap-On Fee increase. Commission Staff recommended increasing the tap on fees to meet the expenses presented in the updated cost justification provided by Garrison-Quincy-KY-O-Heights District. The Commission finds that the increase is approved as it is supported by the expenses contained in the cost justification sheets.

Garrison-Quincy-KY-O-Heights District proposed to decrease its Meter Tap-On Fees for all meter sizes within the Sewer Division from \$4,725 to \$4,688. Commission Staff reviewed the cost justification sheets¹²⁵ provided by Garrison-Quincy-KY-O-Heights District and agreed with the proposed Meter Tap-On Fee decrease. Commission Staff recommended decreasing the tap on fees to meet the expenses presented in the updated cost justification provided by Garrison-Quincy-KY-O-Heights District within the Sewer Division. Although this adjustment does not impact the revenue requirement for the utility, the Commission finds that the decrease is approved as it is supported by the expenses contained in the cost justification sheets.

<u>SUMMARY</u>

After consideration of the evidence of record and being otherwise sufficiently advised, the Commission finds that the recommendations contained in the Commission Staff's Report, along with the above stated modifications, are supported by the evidence of record and are reasonable. By applying the DSC Method to Garrison-Quincy-KY-O-

Heights District pro forma operations results in an Overall Revenue Requirement of \$682,863 and that a \$178,558 revenue increase, or 39.94 percent, to pro forma present revenues is necessary to generate the Overall Revenue Requirement.

IT IS THEREFORE ORDERED that:

- 1. The recommendations contained in the Commission Staff's Report, as modified above, are adopted and incorporated by reference into this Order as if fully set out herein.
- 2. The water service rates proposed by Garrison-Quincy-KY-O-Heights District are denied.
- 3. The water service rates set forth in Appendix B to this Order are approved for service rendered by Garrison-Quincy-KY-O-Heights District on or after the date of service of this Order.
- 4. Within 20 days of the date of service of this Order, Garrison-Quincy-KY-O-Heights District shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and their effective date, and stating that the rates and charges were authorized by this Order.
 - This case is closed and removed from the Commission's docket.
