ORDER

On July 8, 2024,¹ Bluegrass Water Operating Company LLC (Bluegrass Water) filed an application with the Commission, pursuant to KRS 278.020 and 807 KAR 5:001, Section 15 seeking to obtain a Certificate of Public Convenience and Necessity (CPCN) or alternatively, for the Commission to issue a declaratory order, pursuant 807 KAR 5:001, Section 19, and KRS 278.020, if a CPCN is not needed for the installation of a drain field at the Marshall Ridge system. The Commission established a procedural schedule by Order dated August 5, 2024, for orderly processing of the case.

The Commission, on its own motion, finds that the procedural schedule established on August 5, 2024, should be amended to allow for additional time to investigate the proposed drain field.

¹ Bluegrass Water tendered an application on June 26, 2024. In a letter dated June 27, 2024, the PSC notified Bluegrass Water that the application was deficient. Bluegrass Water resolved the deficiencies, and the application was deemed filed on July 8, 2024.

IT IS THEREFORE ORDERED that:

- 1. The procedural schedule established on August 5, 2024, is amended.
- 2. All supplemental requests for information to Bluegrass Water shall be filed no later than October 3, 2024.
- 3. Bluegrass Water shall file responses to supplemental requests for information no later than October 18, 2024.
- 4. That last day for parties to request a public hearing or submit a request for the matter be decided based upon the written record is November 15, 2024.
- 5. All provisions of the Commission's August 5, 2024 Order that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
