ORDER

On May 20, 2025, the Commission issued an Order in this case, which inadvertently failed to address the addition of the 8-inch and 10-inch meter to the monthly sewer rates and failed to account for this in Appendix B. Warren County Water District (Warren District) explained in its application that its Water Division currently provides for a minimum bill for customers who are served through 8-inch and 10-inch meters, and the Sewer Division should also prepare for the possibility of customers who will be receiving water service through such large meters.¹

Finding that the May 20, 2025 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Warren District's request to include minimum bills for customers whose meter sizes exceed six inches, specifically 8-inch and 10-inch meters, is approved.
2. Appendix B of the May 20, 2025 Order is amended to include the following language:

<u>8-Inch Meter</u>	
First 150,000 Gallons	\$661.37 Minimum Bill
Next 850,000 Gallons	0.00410 per gallon

All Over 1,000,000 Gallons 0.00375 per gallon

10-Inch Meter

First 250,000 Gallons \$1,071.37 Minimum Bill


3. All provisions of the May 20, 2025 Order that are not in conflict with the terms of this Order shall remain in effect.

4. Within 20 days of the date of this Order, Warren District shall file with the Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates, charges, and modifications approved or as required herein and reflecting their effective date and that they were authorized by this Order.
