ORDER

On June 6, 2025, the Commission issued an Order in this matter with rates outlined in Appendix B attached to the Order. The Order included rates in the appendix that were not calculated using the most current Fuel Adjustment Clause (FAC) rates. As a result, the rates set forth in the Order are incorrect.

Finding that Appendix B of the June 6, 2025 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Residential-A: Energy Charge: \$0.097656 per kWh is stricken and is replaced with the following language:

Residential-A: Energy Charge: \$0.109669 per kWh.

2. Small Commercial-B: Energy Charge: \$0.081396 per kWh is stricken and is replaced with the following language:

Small Commercial-B: Energy Charge: \$0.093343 per kWh.

3. All other provisions of the Commission's June 6, 2025 Order that are not in conflict with the terms of this Order shall remain in effect.
