ORDER

A hearing in the above-styled matter was held November 3, 2025, through November 6, 2025. At the beginning of the proceeding, the Commission made several findings related to pending motions. On October 20, 2025, Kentucky Utilities Company (KU) and Louisville Gas and Electric Company (LG&E) (jointly, LG&E/KU) filed a joint motion for leave to file a stipulation, supporting testimony and exhibits.¹ The Commission, having reviewed the motion and no party objecting, granted the motion.

On October 31, 2025, Walmart, Inc. filed a motion for leave to allow its witness, Lisa Perry, to testify virtually. Having reviewed the motion and no parties objecting, the Commission granted the request.²

Also, on October 31, 2025, LG&E/KU filed a motion for leave to file supplemental testimony and supporting documentation.³ On November 2, 2025, Kentuckians for the

Commonwealth, Kentucky Solar Energy Society, Metropolitan Housing Coalition, and Mountain Association (together, Joint Intervenors) filed a response in opposition of the motion by LG&E/KU.⁴ In addition to allowing LG&E/KU to speak in support of their motion, before the start of the evidence, the Commission allowed all parties to weigh in on the motion. Joint Intervenors and Sierra Club expressed opposition to the admission of the evidence. At the hearing, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention, and Kentucky Industrial Utility Customers expressed support for the motion. The Commission granted the motion but recessed the hearing for approximately four hours to allow the parties additional time to review the evidence.

During the hearing, the Commission incorporated by reference the record of Case No. 2025-00045,⁵ beginning with filings tendered from May 30, 2025, through the final Order at the request of Joint Intervenors. The Commission did not grant the request of Joint Intervenors to incorporate the record of Case No. 2024-00326.⁶

At the conclusion of the witness testimony, a procedural schedule was established that provided for post-hearing requests for information and briefing.

IT IS THEREFORE ORDERED that:

1. LG&E/KU's October 20, 2025 motion is granted.
