On July 1, 2025, Retail Energy Supply Association (RESA) filed a motion for leave to file requests for information to East Kentucky Power Cooperative, Inc. (EKPC).<sup>1</sup> RESA stated that the motion was timely as its intervention status was still pending.<sup>2</sup> Later that same day, the Commission issued an Order denying RESA's intervention request.<sup>3</sup>

The Commission finds that since RESA's intervention request was denied, the motion for leave to file requests for intervention is denied as moot.

The Commission notes that, while RESA's request for intervention was denied, regulation 807 KAR 5:001, Section 4(11), clearly establishes the right of any person not granted leave to intervene in a cast the right to "file written comments regarding the subject matter of the case." Those comments "shall be filed in the case record."<sup>4</sup> RESA is free to participate in a limited role in this case by filing comments related to this proceeding.
