ORDER

On November 11, 2025, Carl E. Knochelmann Jr., filed a request seeking additional time to file an amended complaint. The Commission had issued an Order on October 20, 2025, finding that Mr. Knochelmann had not established a *prima facie* case pursuant to 807 KAR 5:001, Section 20(4)(a), and permitting him to file an amended complaint within 20 days of the Order. The postal service did not serve him with a copy of the Order until November 7, 2025.¹

Commission regulation 807 KAR 5:001, Section 20(4)(a) allows the Commission to set its own time frame for filing of an amended complaint. The Commission finds good cause exists to extend the time for filing an amended complaint. Mr. Knochelmann's time to file an amended complaint should be extended to November 27, 2025.
