COMMISSION STAFF'S NOTICE OF INFORMAL CONFERENCE

Commission Staff hereby schedules an informal conference on December 10, 2025, at 3 p.m. Eastern Standard Time, to take place at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, to discuss Duke Kentucky's response to Commission Staff's Second Request for Information, Item 5, and the corresponding attachment and Item 3. Commission Staff is requesting that Duke Kentucky explain the specific breakdown of costs it requests to defer, including a narrative description of each expense and how they relate to the Limestone Conversion Project applications, and explanation of any allocated costs (the total cost of the expense, the other entities that share the cost allocation, and how that particular cost was determined in relation to this project). When possible, Duke Kentucky should divide the costs per application filed, with the application case number available. Commission Staff is also requesting that Duke Kentucky provide the net present value workpapers, in Excel spreadsheet format, with all columns, rows, and formulas unprotected and fully accessible, as they relate to the

answer provided in part to Duke Kentucky's response to Commission Staff's Second Request for Information, Item 3.

Commission Staff will contact participants by electronic mail to provide details for joining the conference by video link if a virtual option is needed.
