COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO GREEN RIVER VALLEY WATER DISTRICT

Green River Valley Water District (Green River Valley District), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on January 14, 2026. The Commission directs Green River Valley District to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Green River Valley District shall make timely amendment to any prior response if Green River Valley District obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Green River Valley District fails or refuses to furnish all or part of the requested information, Green River Valley District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Green River Valley District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. State whether Green River Valley District has identified any system improvement projects in the Hart County Water System and the Wax Water Treatment Plant (WTP). If any system improvements projects have been identified, explain each project and the expected cost.

2. Explain how the proposed transfer of assets is in the public interest.

3. Provide the anticipated journal entries by Uniform System of Accounts (USoA) Account Numbers to record the purchasing transactions.

4. Provide the anticipated journal entries by USoA Account Numbers to record the acquisition of assets and associated depreciation impacts.

5. Refer to the Application, pages 21 and 22, paragraph 52. Explain whether Green River Valley District will seek to replace the one employee from the Wax WTP who has found employment elsewhere. If so, explain how that will impact the monthly payroll expense.

6. Provide a breakdown of the revenue requirement impact of the acquisitions including the following items:

- a. Net operating revenue increase or decrease by expense component;
- b. Net operating expense increase or decrease by expense component;
- c. Annual depreciation, including calculations, for each component for which there are different depreciation lives;
- d. Annual debt service for each debt component;
- e. Twenty percent working capital on debt service amounts in item 6(d);
- f. Total of all items above.
