## COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO EDMONSON COUNTY WATER DISTRICT

Edmonson County Water District (Edmonson District), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on January 14, 2026. The Commission directs Edmonson District to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>1</sup> regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the

information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Edmonson District shall make timely amendment to any prior response if Edmonson District obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Edmonson District fails or refuses to furnish all or part of the requested information, Edmonson District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Edmonson District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Application, Item 16. State the current water loss percentage of the Hart County Water System.

- 2. Refer to Application, Item 17, explain if there has been any recent degradation of service/reliability, or other major problem with the Hart County Water System and the Wax Water Treatment Plant (WTP).
- 3. Refer to Application, Item 18, provide the anticipated journal entries by Uniform System of Accounts (USoA) Account Numbers to record the purchasing transactions.
- 4. Refer to Application, Item 18, provide the anticipated journal entries by USoA Account Numbers to record the sale of assets and associated depreciation impacts.
- 5. Individually, provide the feet of asbestos cement pipe, galvanized pipe, unlined cast iron pipe, and lead pipe currently serving Hart County Water System customers. If the Hart County Water System has any of these types of pipes, provide a map and identify each type of pipe on the map of the service territory.
- 6. Refer to Application, Exhibit 18. Provide the total initial cost and accumulated depreciation amount for each USoA Account Number provided in Exhibit 18.
- 7. Refer to Application, The Proposed Transaction, pages 10–17. Provide a breakdown of the revenue requirement impact of the project including the following items:
  - a. Net operating revenue increase or decrease by expense component;
- b. Net operating expense increase or decrease by expense component;
- c. Annual depreciation, including calculations, for each component for which there are different depreciation lives;

- d. Annual debt service for each debt component;
- e. Twenty percent working capital on debt service amounts listed in

item 7(d);

f. Total of all items above.
