3. Counsel for Henderson County Solar shall file a memorandum brief in support of Henderson County Solar's post-hearing position on or before April 3, 2026.

4. This case shall stand submitted for a decision by the Siting Board effective 12:01 a.m. Eastern Daylight Time, April 8, 2026.




