3. Counsel for Mantle Rock shall file a memorandum brief in support of Mantle Rock's post-hearing position on or before January 15, 2026.


4. This case shall stand submitted for a decision by the Siting Board effective 12:01 a.m. Eastern or Standard Time, January 21, 2026.

GENERATION AND TRANSMISSION SITING








