O R D E R

On January 20, 2026, the Commission entered an Order establishing procedural schedule for post-hearing requests for information, which, in part, established a due date for responses to post-hearing requests for information of January 27, 2026.¹ On January 27, 2026, Kentucky Power Company (Kentucky Power) filed a motion seeking an extension of time to respond to Commission Staff's Request for Information, Items 15 and 16, from January 27, 2026 to January 30, 2026. The Commission finds that this request should be granted due to the volume of information to be provided.

IT IS THEREFORE ORDERED that:

1. The Commission's Order entered January 20, 2026, is amended.
2. Kentucky Power's responses to Commission Staff's Request for

Information, Items 15 and 16, shall be filed on or before January 30, 2026.
