COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION  
TO CITY OF ALBANY

City of Albany (Albany), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on February 13, 2026. The Commission directs Albany to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>1</sup> regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Albany shall make timely amendment to any prior response if Albany obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Albany fails or refuses to furnish all or part of the requested information, Albany shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Albany shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to the invoices sent to Cumberland County Water District for the period of December 15, 2017, through April 8, 2024. Each invoice appears to have a \$5 fee listed on it. Explain what that fee is for and provide documentation for when it was approved for any tariff.

2. Refer to the invoices sent to Cumberland County Water District for the period of April 25, 2024, through December 22, 2025. Starting in April 2024, in place of

the \$5 fee discussed above, there is a variable fee listed on the invoices. Explain what that fee is, how it was calculated, and provide documentation for when it was approved for any tariff.

3. Provide any invoices sent to Cumberland County Water District since the January 12, 2026 filing in this proceeding.

4. Refer to the response of Albany<sup>2</sup> at unnumbered page 2. Provide a copy of the 2009 contract between Albany and Cumberland County Water District.
