## ORDER

On December 30, 2025, Atmos Energy Corporation (Atmos) filed its Gas Cost Adjustment (GCA) to be effective February 1, 2026. On January 14, 2026, Commission Staff issued a Request for Information<sup>1</sup> to Atmos, with responses due January 21, 2026. On January 21, 2026, Atmos filed its responses providing supporting documentation for the proposed Performance Based Rate Recovery Factor (PBRRF) rate.<sup>2</sup> Atmos's previous GCA rate was approved for final meter readings on and after November 1, 2025, in Case No. 2025-00303.<sup>3</sup>

## LEGAL STANDARD

The Commission's standard of review for GCA rates is well settled as stated in KRS 278.274(1):

In determining whether proposed natural gas utility rates are just and reasonable, the commission shall review the utility's gas purchasing practices. The commission may disallow any costs or rates which are deemed to result from imprudent purchasing practices on the part of the utility.

Further, the utility has the burden to prove that the proposed rates are just and reasonable. The Commission may reduce the purchased gas component of the utility's rates, or the rates charged by an affiliated company to the extent the amount is deemed to be unjust or unreasonable.<sup>4</sup>

### DISCUSSION

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that Atmos's report includes revised rates designed to pass on to its sales customers its expected change in wholesale gas costs. Atmos's Expected Gas Cost (EGC) for firm sales customers is \$4.7176 per Mcf, which is a decrease of \$0.4735 per Mcf from the previous EGC of \$5.1911 per Mcf. Atmos's EGC for interruptible sales customers is \$3.5132 per Mcf, which is a decrease of \$0.4682 per Mcf from the previous EGC of \$3.9814 per Mcf. Atmos's report sets out no Refund Factor. Atmos's report sets out a Performance Based Rate Recovery Factor (PBRRF) of \$0.2349 per Mcf, which is a decrease of \$0.0297 from the previous PBRRF of \$0.2646 per Mcf. Atmos's report sets out a Correction Factor (CF) of \$0.0517 per Mcf, which is an increase of \$0.1040 per Mcf from its previous CF of (\$0.0523) per Mcf.

Based on the calculations above, the Commission finds that Atmos's GCA rates are \$5.0042 per Mcf for firm sales customers and \$3.7998 per Mcf for interruptible sales customers. The impact on firm sales customers is a decrease of \$0.3992 per Mcf from the previous GCA of \$5.4034 per Mcf. The impact on interruptible sales customers is a decrease of \$0.3939 per Mcf from the previous GCA of \$4.1937 per Mcf. The Commission finds that the inputs, resulting components and calculation of Atmos's

proposed GCR rate of \$5.0042 per Mcf for firm sales customers and \$3.7998 for interruptible sales customers to be reasonable. The Commission further finds that the rates set forth in the Appendix to this Order are fair, just and reasonable and are approved for final meter readings by Atmos on and after February 1, 2026.

For the purpose of transparency and to maintain a record of information for future use, the Commission finds that Atmos shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCA rate reports. Should Atmos purchase sustainable natural gas from a renewable source during the reporting period of any future GCA reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Atmos and set forth in the Appendix to this Order are approved for final meter readings on and after February 1, 2026.
2. Atmos shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files future GCA rate reports.
3. Atmos shall continue to provide supplemental documentation supporting its PBRRF calculation in future filings when proposing a new rate.
4. Should Atmos purchase sustainable natural gas from a renewable source during the reporting period of any future GCA reports, then the supplier, cost, and amount shall be documented in its cover letter to the Commission.
5. Within 20 days of the date of service of this Order, Atmos shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets


setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

6. This case is closed and removed from the Commission's docket.

The following rates and charges are prescribed for the customers in the area served by Atmos Energy Corporation. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under the authority of the Commission prior to the effective date of this Order.

#### RATES:

Applicable to General Sales Service Rate G-1:

##### Gas Cost Adjustment

To each bill rendered under the above-named rate schedule, there shall be added an amount equal to \$5.0042 per Mcf of gas used during the billing period.

Applicable to Interruptible Sales Service Rate G-2:

##### Gas Cost Adjustment

To each bill rendered under the above-named rate schedule, there shall be added an amount equal to \$3.7998 per Mcf of gas used during the billing period.
