ORDER

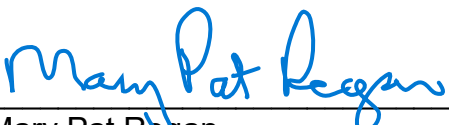
KENTUCKY STATE BOARD ON ELECTRIC GENERATION
AND TRANSMISSION SITING



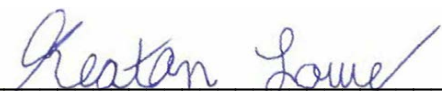
