

COMMONWEALTH OF KENTUCKY BEFORE THE PUBLIC SERVICE COMMISSION

Jeannie Newsome, COMPLAINANT v. KENTUCKY POWER COMPANY, DEFENDANT

FORMAL COMPLAINT

The Complainant, Jeannie Newsome, an educator residing at **154 Tollie Lane**, Pikeville, KY, respectfully shows:

(a) That the Complainant has been a customer of Kentucky Power Company since at least June 2017.

(b) That the Defendant, Kentucky Power Company, has charged the Complainant approximately \$16.00 to \$21.00 monthly for an "Outside Light" service (identified on billing statements) from June 28, 2017, to the present.

(c) That the specific act complained of is a **billing for non-existent service/equipment**. No physical light fixture exists on the Complainant's property, and no such service has ever been provided. Despite this, the Complainant has been billed for nearly 10 years for this service.


(d) That the Complainant attempted to resolve this informally, but on March 13, 2026, was met with unprofessional and dismissive conduct by a Kentucky Power representative who stated the Complainant "should have seen the charge" sooner. Complainant contends that the burden of accurate billing lies with the utility under KRS 278.225.

WHEREFORE, Complainant asks that the Commission order Kentucky Power to:

1. Cease all future charges for the non-existent light service immediately.
2. Provide a full refund or bill credit for all charges collected for this service from June 2017 to the present (approximately \$2,000), plus **statutory interest** as allowed by law .
