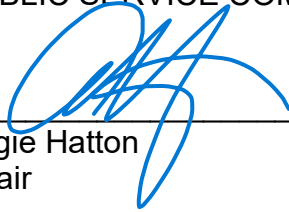
ORDER

On July 1, 2026, Ohio Valley Gas Corporation (Ohio Valley Gas) moved the Commission to admit *pro hac vice* Kay. E. 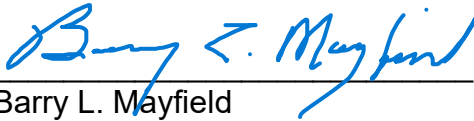
