ORDER

On September 15, 2026, East Kentucky Midstream, LLC (East Kentucky Midstream) filed a motion for an extension to respond to Commission Staff's Second Request for Information (Staff's Second Request) issued on September 3, 2026. The requested information is due on September 18, 2026, and East Kentucky Midstream requested to have until no later than September 28, 2026, to respond.

In support of the motion, East Kentucky Midstream argued that the response time period included a holiday weekend, and the individual schedules and unavailability of persons essential to the preparation and verification of responses have slowed the preparation of responses to Staff's Second Request.¹ East Kentucky Midstream also stated that it has sought and continues to seek information and other assistance from third parties and public and proprietary sources.² East Kentucky Midstream stated that it has not yet received a ruling on its motion for confidential treatment of information provided in response to the initial request for information, which complicates its

preparation of responses.³ East Kentucky Midstream also highlighted that there are no further items on the ordered schedule that depend upon its responses or would otherwise be delayed by the requested extension, and there is no statutory deadline for the Commission's decision in this case.⁴

Having considered the record and being otherwise sufficiently advised, the Commission finds that East Kentucky Midstream's request for additional time should be granted for good cause shown. Allowing East Kentucky Midstream an additional two weeks will not prejudice any party or the customers and will allow East Kentucky Midstream to provide Staff with complete and thorough answers to Staff's questions.

IT IS THEREFORE ORDERED that:

1. East Kentucky Midstream's motion for extension of time is granted.
2. East Kentucky Midstream shall file responses to Commission Staff's September 3, 2026 Request for Information no later than September 28, 2026.

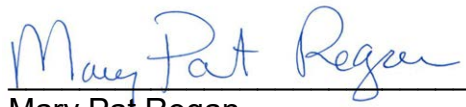

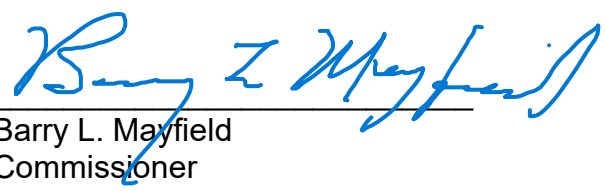
