ORDER

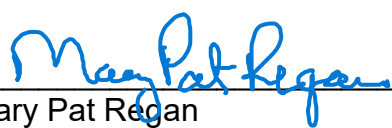
member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.

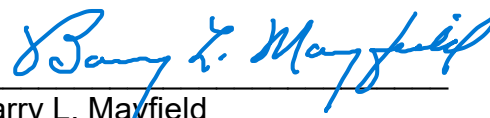
