ORDER

On July 20, 2026, the Commission issued an Order in this matter with a procedural schedule attached as Appendix A.¹ The procedural schedule set the date for East Kentucky Power Cooperative, Inc. (EKPC), and Inter-County Energy Cooperative Corporation (Inter-County Energy) to provide rebuttal testimony as October 6, 2026, a typographical error, as the date for rebuttal testimony should have been listed as November 6, 2026.

Finding that Appendix A of the July 20, 2026 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Appendix A of the July 20, 2026 Order, stating:

EKPC and Inter-County Energy shall file, in verified form, its rebuttal testimony no later than 10/06/2026

is stricken and is replaced with the following language:

EKPC and Inter-County Energy shall file, in verified form, its rebuttal testimony no later than 11/06/2026.

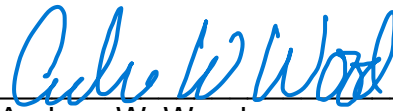
