The utility companies operating in Kentucky, and subject to jurisdiction of the Commission, having reported to the Commission, or the Commission otherwise having the information, their gross receipts derived from intrastate business in Kentucky for the calendar year ended December 31, 1940; and the Commission having determined that its maintenance expense during the fiscal year ending June 30, 1942, will be approximately One Hundred Thirty Thousand (\$130,000) Dollars, the Commission does hereby apportion among and assess the amount of said expenses upon said utility companies in proportion to their gross earnings or receipts derived from intrastate business in Kentucky for the calendar year ended December 31, 1940, as set forth as follows:
