AMENDED ORDER

On September 12, 1979, the Commission entered an Order for the purpose of setting forth its final determinations in this matter.

The Commission after review of the said Order finds:

1. That by means of a clerical error, the rate schedules attached to the Order as Appendix "A" were not the appropriate rate schedules for the Hendron Water District.
2. That the Hendron Water District has informed the Commission that the inappropriate rates have not been implemented and that the rates set forth by the Interim Order of April 20, 1979 are still in effect as the District's official rates.
3. That Amended Appendix "A" attached hereto and made a part hereof should be substituted for Appendix "A" which was attached to the Order entered September 12, 1979 in this matter.
4. That all other provisions of the Commission's Order of September 12, 1979, in this matter, not in conflict with the provisions of this Amended Order should remain in full force and effect.

IT IS THEREFORE ORDERED that the rates and charges proposed by the District's original application in this matter as set forth in Amended Appendix "A", attached hereto be and they are hereby fixed as the fair, just, and reasonable rates and charges of the Hendron Water District to become effective for services rendered on and after the date of this Order.

IT IS FURTHER ORDERED that all other provisions of the Commission's Order of September 12, 1979 in this matter, not in conflict with the provisions of the Amended Order, shall remain in full force and effect.

IT IS FURTHER ORDERED that the Hendron Water District shall, within thirty (30) days of the date of this Order, file its revised tariff sheets with this Commission. Said tariff sheets shall set forth the rates herein approved. Further, the District's Rules and Regulations for providing water services to its customers shall be filed with the said tariff sheets.

AMENDED APPENDIX "A"

APPENDIX TO AN ORDER OF THE UTILITY REGULATORY
COMMISSION IN CASE NO. 7368 DATED MARCH 13, 1980.

The following rates and charges are hereby prescribed for all the customers served by the Hendron Water District. All other rates and charges not mentioned specifically herein shall remain the same as those in effect prior to the date of this Order.

<u>Gallonge Blocks For A 5/8-Inch x 3/4-Inch Meter</u>		<u>Monthly Rate For Each Gallonge Block</u>
First	2,000 gallons	\$ 5.25 (Minimum Bill)
Next	3,000 gallons	2.55 per 1,000 gallons
Next	5,000 gallons	2.30 per 1,000 gallons
Next	10,000 gallons	2.00 per 1,000 gallons
Next	30,000 gallons	1.90 per 1,000 gallons
Next	50,000 gallons	1.75 per 1,000 gallons
Over	100,000 gallons	1.70 per 1,000 gallons

All customers with meters larger than a 5/8" x 3/4" are to be charged according to the above schedule. The gallonge for minimum bills for these meters shall be as follows:

<u>Meter Size</u>	<u>Minimum Gallonge</u>
3/4-Inch	3,500 gallons per month
1-Inch	5,000 gallons per month
1½-Inch	10,000 gallons per month
2-Inch	20,000 gallons per month

A \$3.00 per month surcharge is added to the minimum bill in the area described as Project No. PFL-KY-206. A map of which is on file in the Utility office.
