ORDER

On September 2, 1980, this Commission established just and reasonable rates for the South Central Bell Telephone Company in the above-captioned proceeding. On November 26, 1980, the Franklin Circuit Court set aside these rates and prescribed new rates to take effect immediately. The Commission will appeal this action of the Franklin Circuit Court to the Kentucky Court of Appeals forthwith. 1/ In the meantime, however, we are forced to comply with the Franklin Circuit Court's order and raise the rates to Bell's customers by \$2.1 million pursuant to the new schedule attached as Appendix "A" to this order. Such rates will remain in effect until such time as the appellate courts of this Commonwealth review the action of the Franklin Circuit Court and issue an opinion therein.

Based upon the facts as set forth above and being advised, the Commission hereby ORDERS that South Central Bell Telephone Company is hereby authorized to place into effect the rates set forth in Appendix "A" to this order until such time as the appellate courts make a final determination on this matter.

IT IS FURTHER ORDERED, that South Central Bell Telephone Company shall maintain its records in such manner as will enable it, or the Commission or any of its customers to determine the amounts to be refunded and to whom due in the event that the court prescribed rates are set aside on appeal.

^{1/} In Energy Regulatory Commission v. Kentucky Power Company, 27 K.L.S. 14, the Kentucky Court of Appeals explicitly stated that a reviewing court has no power to prescribe rates for a utility.
