ORDER

On April 23, 1981, the Commission issued its Order in Case No. 7897 approving certain rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On December 14, 1981, Auxier Road Gas Company ("Auxier") notified the Commission that its wholesale cost of gas would be increased by its supplier, Columbia Gas of Kentucky, Inc. ("Columbia") on January 1, 1982, and submitted with its notice certain information in compliance with this Commission's Order of April 23, 1981. The notice set out certain revisions in rates which Auxier proposed to place in effect, said rates being designed to increase the cost of natural gas of its supplier.

The amount of the increased cost of gas to Auxier will be \$9,765 on an annual basis.

After reviewing this evidence of record and being advised, the Commission is of the opinion and finds that:

- (1) Auxier's supplier has filed increased rates and said rates will become effective on and after January 1, 1982.
- (2) Auxier's adjustment in rates under the purchased gas adjustment clause approved by the Commission in its Order in Case No. 7897, dated April 23, 1981, is fair, just and reasonable in the public interest and should be allowed to be effective with gas supplied on and after January 1, 1982.

IT IS THEREFORE ORDERED that the purchased gas adjustment sought by Auxier be and the same is hereby approved to be effective with gas supplied on and after January 1, 1982, as in Appendix A attached hereto and made a part hereof.

IT IS FURTHER ORDERED that for the purpose of the future application of the purchased gas adjustment clause of Auxier the base rate for purchased gas shall be:

Commodity

Columbia Gas of Kentucky, Inc.

\$4.243 per Mcf

IT IS FURTHER ORDERED that the information furnished this Commission by Auxier on December 14, 1981, constitutes full compliance with this Commission's Order in Case No. 7897, and any other information ordinarily required to be filed under the Commission's rules is hereby waived.

IT IS FURTHER ORDERED that within 30 days after the date of this Order, Auxier shall file with this Commission its tariff sheets setting out the rates approved herein.
