O R D E R

On August 9, 1982, Pulaski County Water District No. 1 ("Pulaski County") filed its application seeking authority to adjust its rates in accordance with 807 KAR 5:067, Purchased Water Adjustment Clause. Pulaski County's supplier, Kentucky Water Service Company, Inc., notified Pulaski County of an increase in the wholesale cost of water from \$1.10 to \$1.25 per 1,000 gallons pursuant to an Order of the Public Service Commission in Case No. 8370, Notice of Kentucky Water Service Company, Inc., of Adjustment of Water Rates, dated April 9, 1982.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

(1) Pulaski County's supplier, Kentucky Water Service Company, Inc., increased the wholesale cost of water to \$1.25 per 1,000 gallons, effective April 9, 1982.

(2) The financial exhibits filed by Pulaski County indicate that it cannot absorb the increased cost of wholesale water.

(3) The calculation for the purchased water adjustment in the amount of \$.17 per 1,000 gallons made by Pulaski County is correct and should be approved.

(4) The base rate for future application of the purchased water adjustment clause should be:

<u>Supplier</u>	<u>Rate</u>
Kentucky Water Service Company, Inc.	\$1.25 per 1,000 gallons

(5) The rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment in the amount of \$.17 per 1,000 gallons and the rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.


IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of Pulaski County, the base rate for purchased water shall be:

<u>Supplier</u>	<u>Rate</u>
Kentucky Water Service Company, Inc.	\$1.25 per 1,000 gallons

IT IS FURTHER ORDERED that within 30 days of the date of this Order, Pulaski County shall file with the Commission its revised tariff sheets setting out the rates approved herein.

COMMISSION IN CASE NO. 7911-1 DATED SEPTEMBER
7, 1982

The following rates are prescribed for the customers of Pulaski County Water District No. 1. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

GALLONAGE BLOCK

RATE

First 1,000 gals.	\$5.52 per 1,000 gals.(minimum)
Next 4,000 gals.	2.32 per 1,000 gals.
Next 5,000 gals.	2.07 per 1,000 gals.
Over 10,000 gals.	1.77 per 1,000 gals.

MINIMUM MONTHLY CHARGES

5/8 or 3/4-inch meter	First 1,000 gals.	\$5.52 Minimum
1-inch meter	First 1,500 gals.	6.69 Minimum
1 1/4 or 1 1/2-inch meter	First 2,000 gals.	7.84 Minimum
2-inch meter	First 2,500 gals.	9.01 Minimum
3-inch meter	First 3,500 gals.	11.33 Minimum
4-inch meter	First 9,000 gals.	23.08 Minimum
5-inch meter	First 25,000 gals.	51.70 Minimum
