O R D E R

On September 17, 1982, the Electric and Water Plant Board of Frankfort, Kentucky, ("Frankfort") and Dickerson Lumber Co., Inc., ("Dickerson") by counsel, filed motions to intervene in the above case. Dickerson also filed a motion to extend its time for pre-filing testimony until September 28, 1982, based upon its recent discovery of new information.

The Commission having considered the motions to intervene and being advised, HEREBY ORDERS that said motions be and they hereby are sustained.

The Commission having considered Dickerson's motion for an extension of time in which to pre-file testimony and being advised that the hearing in which said testimony will be presented will not take place until approximately three weeks after the proposed filing date of September 28, HEREBY ORDERS that said motion be and hereby is sustained.

IT IS FURTHER ORDERED that Frankfort shall immediately serve copies of its testimony upon Dickerson; the Attorney General, Consumer Protection Division; and the utilities which are a party to this proceeding, except the distribution cooperatives, which shall be served through the appropriate generation and transmission corporation.

IT IS FURTHER ORDERED that Dickerson shall immediately serve copies of its testimony upon East Kentucky Power Cooperative, Inc., and the Attorney General, Consumer Protection Division.
