ORDER

On October 13, 1980, the Commission issued its Order in Case No. 7800 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On August 11, 1983, Mt. Olivet Natural Gas Company, Inc., ("Mt. Olivet") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas Transmission Corporation ("Transmission"), effective September 1, 1983, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Mt. Olivet's notice of August 11, 1983, set out certain revisions in rates which Mt. Olivet proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$2,027 or 4.6 cents per Dth.

(2) Transmission has filed an application for decreased rates to become effective September 1, 1983, with the Federal Energy Regulatory Commission.

(3) Mt. Olivet's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 7800 dated October 13, 1980, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after September 1, 1983.


IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after September 1, 1983.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Mt. Olivet shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE PUBLIC SERVICE
COMMISSION TO CASE NO. 7800-U DATED AUGUST 22, 1983

The following rates and charges are prescribed for the customers served by Mt. Olivet Natural Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the date of this Order.

RATES: Monthly

First 1,000 cu. ft. or less	\$7.79 (Minimum Bill)
Next 4,000 cu. ft., per 1,000 cu. ft.	6.050
Next 5,000 cu. ft., per 1,000 cu. ft.	5.850
Next 10,000 cu. ft., per 1,000 cu. ft.	5.700
Over 20,000 cu. ft., per 1,000 cu. ft.	5.500
