## ORDER

On May 30, 1984, East Pendleton Water District ("East Pendleton") filed its application with the Public Service Commission ("Commission") seeking authority to adjust its rates in accordance with 807 KAR 5:067, Purchased Water Adjustment Clause. Subsequently, the Commission requested that additional information be filed. The required information was filed on June 28, 1984, and July 24, 1984, respectively, and the record is now complete.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

(1) Effective July 1, 1984, East Pendleton's supplier, City of Falmouth, changed its rate design and increased its rates for wholesale water from a flat rate of \$.75 per 1,000 gallons to a declining block rate design consisting of five rate steps, the lowest of which is \$.94 per 1,000 gallons.

(2) The statements of water purchased and sold filed by East Pendleton for the 12-month period ending April 30, 1984, show that its water loss is approximately 22 percent which is in excess of the maximum of 15 percent allowed by the Commission.



(3) After adjustments for water loss, the total allowable increase in purchased water costs is \$9,479, resulting in a purchased water adjustment of \$.22 per 1,000 gallons.


(4) The financial exhibits filed by East Pendleton indicate that it cannot absorb an increase of this magnitude in the wholesale cost of water.

(5) The purchased water adjustment in the amount of \$.22 per 1,000 gallons and the rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment in the amount of \$.22 per 1,000 gallons and the rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of East Pendleton, the base rates for purchased water shall be:
