O R D E R

Pursuant to 807 KAR 5:056, Section 1(11), the Public Service Commission ("Commission") HEREBY ORDERS that Louisville Gas and Electric Company ("LG&E") shall appear at the Commission's offices in Frankfort, Kentucky, on January 19, 1984, at 9:00 a.m., Eastern Standard Time, for the purpose of examining the application of the Fuel Adjustment Clause from May 1, 1983, to October 31, 1983.

IT IS FURTHER ORDERED that LG&E shall give proper notice to its customers of the date, time, place, and purpose of the hearing.

IT IS FURTHER ORDERED that LG&E shall, on or before January 6, 1984, file an original and 10 copies of a schedule showing the calculation of the monthly over- or under-recovery of fuel costs, from May 1, 1983, through October 31, 1983.

IT IS FURTHER ORDERED that LG&E shall, on or before January 6, 1984, file an original and 10 copies of scheduled, actual and forced outages for the 6-month period May 1, 1983, to October 31, 1983.
