## ORDER

IT IS ORDERED that Muhlenberg County Water District ("Muhlenberg County") shall file an original and six copies of the following information with the Commission by November 26, 1984. Muhlenberg County shall furnish the name of the witness who will be available at the public hearing to respond to questions concerning each item of information provided. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case may be dismissed.

- 1. Please file the following information pursuant to 807 KAR 5:001, Section 9, corresponding to the test year ended December 31, 1983.
  - a. Item 1(a) A financial exhibit for the 12 month period ending not more than 90 days prior to the date the application is filed in accordance with 807 KAR 5:001, Section 6. A detailed income statement and balance sheet shall be included in the financial exhibit.

- b. Item 1(b) A schedule of the present rates, tolls, charges, or rentals, in effect, and the changes which it is desired to make, shown in comparative form.
- c. Item 1(c) A description of Muhlenberg's property including a statement of the net original cost of the property (estimated if not known) and the cost thereof to Muhlemberg County.
- d. Item 1(d) A statement in full of the reason why the adjustment is required.
- e. Item 1(e) A statement setting forth estimates of the effect that the new rate or rates will have upon the revenues of Muhlenberg County, the total amount of money resulting from the increase, the percentage of increase, and the effect upon the average consumer bill.
- f. Item 1(f) A statement certifying that the annual reports, including the report for the most recent calendar year, are on file with the Commission in accordance with 807 KAR 5:006, Section 3(1).
- g. Item 2 Complete financial date for the 12 months corresponding to the test year ended December 31, 1983.
- h. Item 2(a) Provide in the financial data the total amount of interest charged to construction.

- i. Item 2(b) A billing analysis covering the entire test year in such detail that the revenues from the present and proposed rates can be readily determined.
- j. Item 2(c) Details of any apportionment used.
- k. Item 2(d) Statement of monthly revenues and operating expenses.
- 2. Are all current special charges compensatory? If not, please provide cost justification, using the attached forms, to justify an increase in these charges to cover the costs connected with providing these services.
