O R D E R

On November 20, 1986, General Telephone Company of the South ("GenTel"), by counsel, filed a Motion for an extension of time in which to respond to the Commission's information order dated November 14, 1986, and to the Attorney General's First Request for Information submitted on November 14, 1986. GenTel has asked for an extension to and including December 5, 1986, to respond to the Commission's Order and to and including December 12, 1986, to answer the Attorney General's Request. The Commission, having considered the Motion and being advised, finds that, if the Motion is granted, events require acceptance of GenTel's offer to waive the suspension period for an amount of time corresponding to this extension.

IT IS THEREFORE ORDERED that:

1. GenTel's motion be and it hereby is granted.
2. The revised procedural schedule listed in Appendix A shall be followed.

5. Intervenors shall file their testimony in verified prepared form, unless submitted sooner... 1/20/87
6. All requests for information to intervenors shall be due, unless submitted sooner..... 1/29/87
7. Intervenors shall mail or deliver responses to requests for information, unless submitted sooner..... 2/10/87
8. Public Hearings are to begin at 9:00 a.m., Eastern Standard Time, in the Commission's Offices at Frankfort, Kentucky, for the purpose of cross-examination of witnesses of GenTel, cross-examination of witnesses of intervenors, and the presentation of rebuttal testimony, if any..... 2/18/87
9. GenTel and intervenors shall, if necessary, file briefs, indexed by subject matter, simultaneously..... 3/6/87
