ORDER

On June 10, 1987, the Commission issued an Order granting Long Distance Telephone Savers, Inc., ("LDTS") a Certificate of Public Convenience and Necessity to resell WATS within Kentucky, subject to conditions described in that Order. On July 14, 1987, LDTS filed a motion to reconsider paragraph 5 of the June 10 Order. This paragraph requires LDTS to file a tariff amendment reflecting the exact number of free seconds allowed before chargeable time begins.

In its motion, LDTS acknowledged that the Commission has a legitimate purpose in requesting this information since it could alleviate customer concerns about charges for uncompleted calls. However, LDTS expressed its concern about the potential opportunity for abuse if the number of free seconds is publicly available in its tariff. The Commission is of the opinion that these concerns are valid and will therefore amend the June 10, 1987, Order by vacating Finding Paragraph 5 and modifying Ordering Paragraph 4 to reflect the vacated Finding. However, the Commission will continue to monitor this situation and may require future tariff amendments if necessary to protect the public interest. Since the Commission is not requiring a tariff amendment at this time, the request of LDTS for confidential treatment of this information is moot.

FINDINGS AND ORDERS

The Commission, having considered the evidence of record and being advised, is of the opinion and finds that:

- 1. LDTS' concern about the potential opportunity for abuse if the number of free seconds were publicly available in its tariff is a valid concern.
- 2. The June 10, 1987, Order in this case should be amended by vacating Finding Paragraph 5 and modifying Ordering Paragraph 4 to read: "Within 30 days from the date of this Order LDTS shall file its tariff sheets as specified in Finding 4."

IT IS THEREFORE ORDERED that the June 10, 1987, Order in this case be and hereby is amended by vacating Finding Paragraph 5 and modifying Ordering Paragraph 4 to read: "Within 30 days from the date of this Order LDTS shall file its tariff sheets as specified in Finding 4."
