O R D E R

On October 9, 1987, Jackson Purchase RECC ("Jackson") filed with the Commission a proposed tariff to decrease the existing rates now being charged for 175 and 400 watt Mercury Vapor Outdoor Lights. The proposed rates are to become effective November 12, 1987.

The proposed decrease in rates is the result of a new security light cost analysis that Jackson recently completed and will reduce the annual revenue \$99,524.

After review of the records and being advised, the Commission is of the opinion and finds that:

1. The new security light cost analysis filed by Jackson indicates that the rates proposed for 175 and 400 watt Mercury Vapor Outdoor Lights are cost justified.
2. By reducing the annual revenue \$99,524 Jackson's TIER will not be below the level found reasonable by the Commission in Case No. 8863 Final Order dated 12/29/83.
3. Jackson gave proper notice to the public of the proposed rate decrease by publishing the change in the newspaper.

4. The proposed decrease in security light rates is for an ongoing service and not a general decrease in rates. Good cause exists to grant a waiver of the filing requirements set forth in 807 KAR 5:001, Section 8 and Section 10 since Jackson has substantially complied with those requirements.


IT IS THEREFORE ORDERED that:


1. Jackson is hereby granted a waiver of the filing requirement set forth in 807 KAR 5:001, Section 8 and Section 10.


