O R D E R

On November 14, 1988, Pendleton County Water District ("Pendleton") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to KRS 278.015 and 807 KAR 5:068, Purchased Water Adjustment.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

1. Pendleton purchases water from Campbell County Kentucky Water District ("Campbell") and the City of Falmouth ("City").
2. Pursuant to the Commission's Order dated November 21, 1988 in Case No. 10420, Purchased Water Adjustment of Campbell County Kentucky Water District, Campbell increased its rate for water sold to Pendleton from \$.88 to \$1.14 per 1,000 gallons, effective December 1, 1988. There has been no change in the rates charged by the City.
3. Pendleton proposed to increase the rates to its customers effective December 16, 1988.
4. During the 12 months ending August 31, 1988, Pendleton purchased 55,497,710 gallons of water from Campbell and 19,508,000

gallons from the City. Pendleton sold 68,406,750 gallons of water during the same 12-month period.

5. Pendleton's calculations are incorrect in that the changed rate used differs from that granted in Case No. 10420. The correct increase in purchased water costs is \$14,429, resulting in a purchased water adjustment of \$.21 per 1,000 gallons as shown in Appendix B.

6. The purchased water adjustment of \$.21 per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment and rates proposed by Pendleton are denied.

2. The purchased water adjustment of \$.21 per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after December 16, 1988.

3. Within 30 days of the date of this Order, Pendleton shall file a revised tariff setting out the rates approved herein.

Increase: \$14,429.41

\$14,429.41 ÷ 68,406.750 m. gals. = \$.2109 or \$.21 per 1,000 gals.
