O R D E R

On March 10, 1987, the Attorney General of Kentucky ("AG"), by and through his Utility and Rate Intervention Division, filed a Motion for Extension of Time until April 14, 1987, in which to file prepared testimony in these cases. The AG stated as its basis for this request that it anticipated it would be as late as April 1, 1987, before all data requested in its information requests was furnished.

The Commission, finds that in order for these cases to proceed expeditiously all utilities that have not yet responded to the AG's request should do so by March 23, 1987, and that the AG and all other intervenors should file prepared testimony by April 6, 1987.

IT IS THEREFORE ORDERED that:

1. All utilities shall provide their responses to the AG's request by March 23, 1987.

2. All intervenors in this case shall have until April 6, 1987, to file prepared testimony.
