O R D E R

On November 30, 1987, Berea College Electric Utility ("Berea") filed an application for adjustment of rates to become effective for service rendered on or after January 1, 1988.

The Commission finds that proceedings are necessary in order to determine the reasonableness of the proposed rates and suspends the proposed rates until June 1, 1988.

The Commission, also finds pursuant to KRS 278.190, that further proceedings are necessary and is of the opinion and finds that a procedural schedule is warranted in this case.

IT IS THEREFORE ORDERED that:

1. The rates proposed in the Notice are suspended until June 1, 1988.

2. Berea shall provide public notice of the proposed rates in accordance with the provisions set out in 807 KAR 5:011, Section 8(2) and (3).

3. The notice or publication shall also contain the following language:

The rates contained in this notice are the rates proposed by Berea College Electric Utility. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such

action may result in rates for consumers other than the rates in this notice.

4. The procedural schedule set out in Appendix A to this Order be and it hereby is adopted.

5. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 12 copies to the Commission.


6. Berea shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).


7. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

2. Berea College Electric Utility shall mail or deliver responses to the original requests for information within 14 days of receipt but no later than.....January 22, 1988
3. All supplemental requests for information (to include only those matters within the scope of the initial requests) to Berea College Electric Utility shall be due no later than.....February 2, 1988
4. Berea College Electric Utility shall mail or deliver responses to supplemental requests for information within 14 days of receipt but no later than.....February 16, 1988
5. Intervenors and Staff shall file their testimony in verified prepared form no later than.....February 29, 1988
6. All requests for information to Staff and Intervenors shall be due no later than.....March 14, 1988
7. Staff and Intervenors shall mail or deliver responses to requests for information within 14 days of receipt but no later than.....March 28, 1988
8. Public Hearings are to begin at 9:00 a.m., Eastern Standard Time, in the Commission's offices at Frankfort, Kentucky, for the purpose of cross-examination of witnesses of Berea College Electric Utility, cross-examination of witnesses of the Staff and Intervenors, and the presentation of rebuttal testimony, if any.....April 12, 1988
9. Briefs due, if required.....May 2, 1988
10. Suspension Period ends.....June 1, 1988
