O R D E R

On November 16, 1987, Boone County Water and Sewer District ("Boone") filed its revised tariff sheets with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to KRS 278.015 and 807 KAR 5:068, Purchased Water Adjustment.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

1. Boone's supplier, Kenton County Water District No. 1, increased its rate for purchased water from \$.68 to \$.83 per 1,000 gallons of water, effective October 1, 1987.
2. Boone increased the rates to its customers effective December 1, 1987.
3. During the 12 months ending October 31, 1987, Boone purchased 610,869,400 gallons of water and sold 557,416,345 gallons.
4. Boone's calculations are correct and show an increase in purchased water costs of \$91,630, resulting in a purchased water adjustment of \$.16 per 1,000 gallons.

5. Boone's tariff is incorrect in that an incorrect rate is shown for tank sales to water haulers. The correct rate, including the purchased water adjustment is \$1.66 per 1,000 gallons.

6. The purchased water adjustment in the amount of \$.16 per 1,000 gallons and the rates in Appendix A are fair, just and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The purchased water adjustment in the amount of \$.16 per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after December 1, 1987.

2. Within 30 days of the date of this Order, Boone shall file revised tariff sheets setting out the rates approved herein.
