ORDER

On January 26, 2005, East Kentucky Network, LLC d/b/a Appalachian Wireless ("Appalachian Wireless") filed an application seeking Eligible Telecommunications Carrier ("ETC") status within the territory of which it is licensed to operate. The Commission set a procedural schedule in this case that allowed for any public comments, data requests, and hearing requests. No comments on the application were filed and no hearing was requested.

Appalachian Wireless sought ETC designation in many areas of Eastern Kentucky, including the Pikeville exchange in the territory of BellSouth Telecommunications, LLC d/b/a AT&T Kentucky ("AT&T Kentucky").<sup>1</sup> The various exchanges requested for ETC designation were listed by the city in which the exchanges were located.

The Commission, on August 11, 2005, granted Appalachian Wireless's application in this case, finding that, "Appalachian Wireless should be certified as an ETC in the requested service areas served by non-rural telephone companies, as listed



in the application.”<sup>2</sup> The Commission ordered that, “Appalachian Wireless shall be designated an ETC in the geographic areas requested as and listed in Appendix A . . . .”<sup>3</sup> Appendix A listed the wire centers by their common language location identifier (“CLLI”) code in which Appalachian Wireless was designated as an ETC. Due to a clerical oversight, the Commission omitted the CLLI code for one of the two wire centers located in the Pikeville exchange, even though it had held that Appalachian Wireless should receive ETC status in the service areas it had requested in its ETC Petition. The Commission listed CLLI code PKVLKYMA, which is the code for one of the wire centers in the Pikeville exchange. The CLLI code for the other wire center in the Pikeville Exchange is PKVLKYMT, which is the CLLI code that was inadvertently omitted.


Based on the foregoing, the Commission finds that, on its own motion, the August 11, 2005 Order should be amended, *nunc pro tunc*, to include the CLLI code for the other wire center in the Pikeville Exchange.

IT IS THEREFORE ORDERED, *nunc pro tunc*, that Appendix A to the August 11, 2005 Order is amended to include the CLLI code PKVLKYMT.
