ORDER REGARDING REDACTED FILING ORDER REGARDING REQUEST FOR
CONFIDENTIAL TREATMENT

On January 30, 2013, TracFone Wireless, Inc. ("Movant") moved pursuant to 807 KAR 5:001, Section 7, that certain materials filed with the Commission be afforded confidential treatment and not be placed in the public record subject to public inspection. In support of its motion, Movant states that the information it is requesting to be held confidential is not publicly available and the disclosure of which would compromise Movant's competitive position in the industry, which would result in an unfair commercial advantage to Movant's competitors. Movant notes that the Commission has granted this information confidential treatment in previous quarterly reports.

It is accurate that the Commission has provided confidential treatment to other quarterly reports. In previous filings in this case, the information provided to the Commission included the number of customers that: (1) had been de-enrolled; (2) did not pass the annual verification; and, (3) voluntarily de-enrolled. However, the information for which Movant seeks confidential treatment is now made publicly

available on an annual basis in filings at the Federal Communication Commission (“FCC”) at the following website: <http://www.usac.org/li/tools/disbursements/default.aspx>.

Having carefully considered the motion and the materials at issue, the Commission finds that:

1. The information for which confidential treatment is sought is publicly available at the FCC.
2. Movant’s motion for confidential treatment should be denied.


IT IS THEREFORE ORDERED that:
