ORDER

On March 12, 2013, Menifee County Board of Education ("Menifee County") filed a motion for a 30-day extension of time to file its verified direct testimony, originally due on March 18, 2013. In support of its motion, Menifee County states that its new attorney and the attorney for Clark Energy Cooperative, Inc. ("Clark Energy") have begun renewed settlement negotiations, and that Clark Energy has sent it a settlement offer that it would like to consider. It states that due to recent snow days in the district, as well as the recentness of the settlement offer, it has not had a chance to properly convene and consider the offer. It requests a 30-day extension in order to call a special meeting and consider Clark Energy's settlement offer.


