ORDER

On May 24, 2013, Kentucky Utilities Company ("KU") filed a motion requesting the Commission to correct the \$9.96 annual rate for the Cable Television Attachment Charge ("CTAC") as approved by Order entered on December 20, 2012 in this case. In that Order the Commission approved new base rates as well as other rates and charges for KU, including a \$9.96 CTAC rate, all as agreed to by all parties and set forth in a unanimous Settlement Agreement, Stipulation, and Recommendation ("Settlement Agreement").<sup>1</sup>

KU's Motion states that it calculated the CTAC rate correctly, but inverted the last two numbers when preparing the proposed tariffs. Thus, the CTAC rate should have been \$9.69, rather than \$9.96.

On May 31, 2013, KU filed copies of electronic mail communications between it and the parties to the Settlement Agreement showing that each party has been notified of KU's proposed correction and that no party objects to the CTAC correction. KU states that the correction to the CTAC rate is revenue neutral and has no impact on the other rates and charges approved in the December 20, 2012 Order. KU also states that, because CTAC customers are billed on a six-month basis, CTAC customers' bills

for the period January 1, 2013 through June 30, 2013 have not yet been issued. Consequently, upon correction of the CTAC rate, bills for those customers will be issued in July and no refunds will be due.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that KU has shown good cause to reopen this case and grant its request to correct an error contained in the December 20, 2012 Order by changing the approved CTAC rate from \$9.96 per year to \$9.69 per year.


IT IS THEREFORE ORDERED that:

1. This case is reopened for the limited purpose of granting KU's motion to correct an error in the CTAC rate approved in the December 20, 2012 Order.
2. KU's motion is granted and the December 20, 2012 Order is corrected *Nunc Pro Tunc* by changing the approved CTAC rate in Exhibit B, page 6, from \$9.96 per year per attachment to \$9.69 per year per attachment.
3. KU's proposed CTAC tariff attached as Exhibit 2 to its Motion is approved as filed.
4. All other provisions of the December 20, 2012 Order shall remain in full force and effect.
5. This case is closed and removed from the Commission's docket.
