ORDER

West Carroll Water District has moved for additional time to respond to the contents of Commission Staff's Report on the proposed rate adjustment. Finding that good cause exists to grant the motion, the Commission HEREBY ORDERS that:

1. West Carroll Water District's motion for an extension of time to respond to the Commission Staff report is granted.
2. The parties shall file with the Commission their written comments on, and any objections to, the findings and recommendations contained in the Commission Staff Report no later than February 28, 2013. Any party may file with such submission any additional evidence for the Commission's consideration.
3. A party's failure to file written objections to a finding or recommendation contained in the Commission Staff Report by February 28, 2013 shall be deemed as agreement with that finding or recommendation.
4. No later than February 28, 2013, each party shall notify the Commission in writing whether this matter may be submitted for decision based upon the existing record without hearing.

5. Unless all parties request that this matter be submitted for decision upon the existing record:

a. An informal conference shall be held in this matter on March 14, 2013, at 1:00 p.m. Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

b. A formal hearing in this matter shall be held at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky on March 27, 2013, beginning at 10:00 a.m., Eastern Daylight Time.

c. Each party shall file with the Commission, no later than March 20, 2013, a list of the persons it intends to call as witnesses at the scheduled hearing and a summary of each witness's testimony.


d. West Carroll shall publish notice of the scheduled hearing in accordance with 807 KAR 5:076, Section 11, no more than 21 days and no less than 7 days before the day of the scheduled hearing.

6. All provisions of the Commission's Orders of November 29, 2012 and of January 4, 2013 that conflict with the provisions of this Order are vacated. All other provisions of the Orders of November 29, 2012 and of January 4, 2013 shall remain in effect.
