
ORDER

This matter arises upon the joint motion of South Kentucky Rural Electric Cooperative Corporation, Cumberland Valley Electric, Inc., Farmers Rural Electric Cooperative Corporation, Blue Grass Energy Corporation, Big Sandy Rural Electric Cooperative Corporation, Licking Valley Rural Electric Cooperative Corporation, Inter-County Energy Cooperative Corporation, Nolin Rural Electric Cooperative Corporation and Clark Energy Cooperative, Inc. ("Joint Movants") filed July 30, 2013 for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission, being otherwise sufficiently advised, finds that the Joint Movants should be granted full rights of a party in this proceeding.

IT IS HEREBY ORDERED that:

1. The motion of the Joint Movants to intervene is granted.
2. The Joint Movants shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
3. Should the Joint Movants file documents of any kind with the Commission in the course of these proceedings, the Joint Movants shall also serve a copy of said documents on all other parties of record.
