ORDER


This matter arises upon the motion of Community Action Council for Lexington, Bourbon, Harrison and Nicholas Counties, Inc. ("CAC") for full intervention. Having been otherwise sufficiently advised, the Commission finds that CAC is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings and that CAC should be granted full rights of a party in this proceeding.

IT IS HEREBY ORDERED that:


1. The motion of CAC to intervene is granted.
2. CAC shall be entitled to the full rights of a party and, pursuant to the provisions of the Commission's Order of December 17, 2012, shall be served with electronic notice of the issuance of all Commission Orders issued after the date of this Order and of all documents filed by any party to this proceeding.
3. Within seven days of the date of this Order, CAC shall file with the Commission a written statement that it waives any right to service of Commission orders by United States mail and that it or its authorized agent possesses the facilities to receive electronic transmissions.

4. CAC shall comply with all provisions of the Commission's Order of December 17, 2012 related to the electronic filing of documents.
