ORDER


On June 5, 2013, Alcan Primary Products Corporation ("Alcan") filed a motion for authority to withdraw as a party to this case. Alcan had previously filed on January 11, 2013 a motion to intervene, citing as support its ownership and operation of an aluminum reduction facility in Sebree, Kentucky, and that electric service represents a significant cost of its business. By Order entered February 12, 2013, the Commission granted Alcan's motion to intervene. The pending motion to withdraw states that on May 31, 2013, Alcan sold substantially all of its assets, which comprise the entirety of the Sebree facility, to an affiliate of Century Aluminum Company and that as a result, Alcan no longer owns the Sebree facility and no longer has an interest in this case.

Based on the motion and finding good cause, the Commission HEREBY ORDERS that Alcan's motion to withdraw as a party and for its counsel of record to withdraw is granted.
