ORDER

On May 14, 2013, Ben Taylor and Sierra Club (collectively "Sierra Club") filed a motion to amend its Supplemental Requests for Information to Big Rivers Electric Cooperation ("Supplemental Request") by redacting certain confidential information set forth in Item No. 18. Sierra Club states that its Supplemental Request, as filed on May 6, 2013, contains information that had been previously granted confidential treatment pursuant to the Commission's April 25, 2013 Order. Sierra Club acknowledges that it should have made a redacted filing without the confidential information and a confidential filing with such information unredacted, as required by 807 KAR 5:001, Section 13(9). Sierra Club now requests that the Commission remove the Supplemental Request from the public record and replace it with the redacted version attached to its motion, and accept for filing the confidential version of its Supplemental Request, also attached to its motion.

Based on a review of the record and finding good cause, the Commission  
HEREBY ORDERS that:

1. Sierra Club's motion to amend its supplemental requests is granted.

2. Sierra Club's supplemental requests filed on May 6, 2013 shall be removed from the record.

3. Sierra Club's redacted supplemental requests and confidential supplemental requests attached to its motion to amend supplemental requests filed May 14, 2013 are accepted for filing in the case.
